

Verification Analysis of the Redi Rock Wall

In this verification manual you will find hand-made verification analysis of the Redi Rock Wall in a permanent design situation. The results of the hand-made calculations are compared with results from the GEO5 – Redi Rock Wall program.

Terms of Reference:

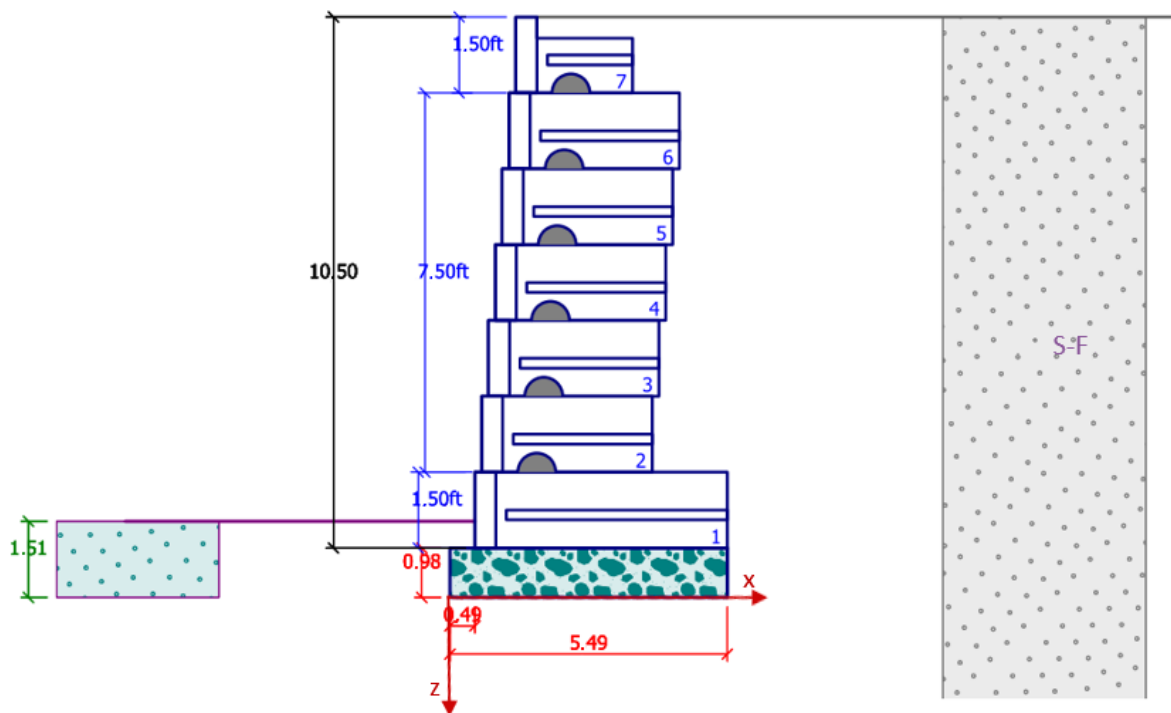


Figure 1 Construction of the Redi Rock Wall – dimensions

In Figure 1, an example of wall is shown. Wall is constructed of the 7 blocks RediRock. Setbacks of the blocks are 1.62 in (0.135 ft). Homogenous soil (silty sand S-F) is considered at the both sides of the wall. Footing from the crushed stone has a thickness 0.98 ft and it is placed below the wall. The properties of soil and footing (effective values) are shown in Table 1. Verification analysis of the wall is performed with the help of safety factors. The bearing capacity of foundation soil is calculated by NCMA standard.

Verification of the Whole Wall

Calculation of the weight and the centroid of the wall. The wall is divided into 8 blocks (7 blocks of RediRock and footing), which are shown in Figure 1. Table 2 shows the dimensions of the blocks, their weights and centroids.

- Centroid of the construction:

$$x_t = \frac{\sum_{i=1}^5 W_i \cdot x_i}{\sum_{i=1}^5 W_i} = \frac{14210.688}{5325.320} = 2.669 \text{ ft}$$

$$z_t = \frac{\sum_{i=1}^5 W_i \cdot z_i}{\sum_{i=1}^5 W_i} = \frac{-26394.553}{5325.320} = -4.956 \text{ ft}$$

Calculation of the front face resistance. The depth of the soil in front of the wall is 1.51 ft. Pressure at rest is considered.

- Coefficient of earth pressure at rest:
(For non-cohesive soils the Jaky formula for computing of the coefficient of earth pressure at rest K_0 is used)
 $K_0 = 1 - \sin \varphi = 1 - \sin(28.00) = 0.531$
- Vertical normal effective stress σ_z in the footing bottom:
 $\sigma_z = \gamma \cdot h = 120.00 \cdot 1.51 = 181.200 \text{ psf}$

- Pressure at rest in the footing bottom:
 $\sigma_0 = \sigma_z \cdot K_0 = 181.200 \cdot 0,531 = 96.217 \text{ psf}$
- Resultant force of stress at rest S_0 :
 (Resultant force S_0 acts only in horizontal direction, therefore $S_0 = S_{0x}$ and $S_{0z} = 0$)

$$S_0 = \frac{1}{2} \cdot \sigma_0 \cdot h = \frac{1}{2} \cdot 96.217 \cdot 1.51 = 72.644 \text{ lbf / ft}$$
- Point of action of the resultant force S_0 :

$$z_0 = -\frac{1}{3}h = -\frac{1}{3} \cdot 1.510 = -0.503 \text{ ft}$$

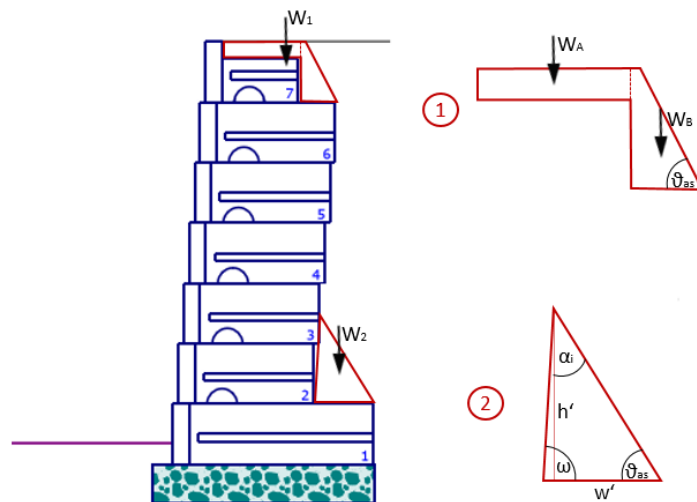


Figure 2 Soil wedges - geometry

Calculation of the weight and the centroid of the soil wedges. In figure 2, two soil wedges are shown. Soil wedges are considered above setbacks and at the back side of the wall. The geometry of both wedges is given by the inclination ϑ_{as} .

- Calculation of the angle α_i is obtained from the iterative formula:

$$\sin^2(\alpha) = \frac{\sin(\varphi - \beta) \cdot \cos(\alpha_i + \varphi)}{2 \cdot \tan(\varphi) \cdot \cos(\alpha_i - \beta)} \rightarrow \alpha_i = \arcsin \left(\sqrt{\frac{\sin(\varphi - \beta) \cdot \cos(\alpha_i + \varphi)}{2 \cdot \tan(\varphi) \cdot \cos(\alpha_i - \beta)}} \right)$$
- $\beta = 0.000^\circ$ - inclination of terrain
- $\alpha_i = 30.000^\circ$ - estimate
- 1st iteration: $\alpha_i = \arcsin \left(\sqrt{\frac{\sin(28.00 - 0.00) \cdot \cos(30.00 + 28.00)}{2 \cdot \tan(28.00) \cdot \cos(30.00 - 0.00)}} \right) = 31.32^\circ$

$$2^{\text{nd}} \text{ iteration: } \alpha_i = \arcsin \left(\sqrt{\frac{\sin(28.00 - 0.00) \cdot \cos(31.32 + 28.00)}{2 \cdot \tan(28.00) \cdot \cos(31.32 - 0.00)}} \right) = 30.90^\circ$$

$$z_B = -0.980 - 1.500 \cdot 6 - \frac{1.500}{3} = -10.480 \text{ ft}$$

- Total weight and centroid of the soil wedge 1:

$$W_1 = W_A + W_B = 76.476 + 93.304 = 169.780 \text{ kN / m}$$

- Total weight and centroid of the soil wedge 2:

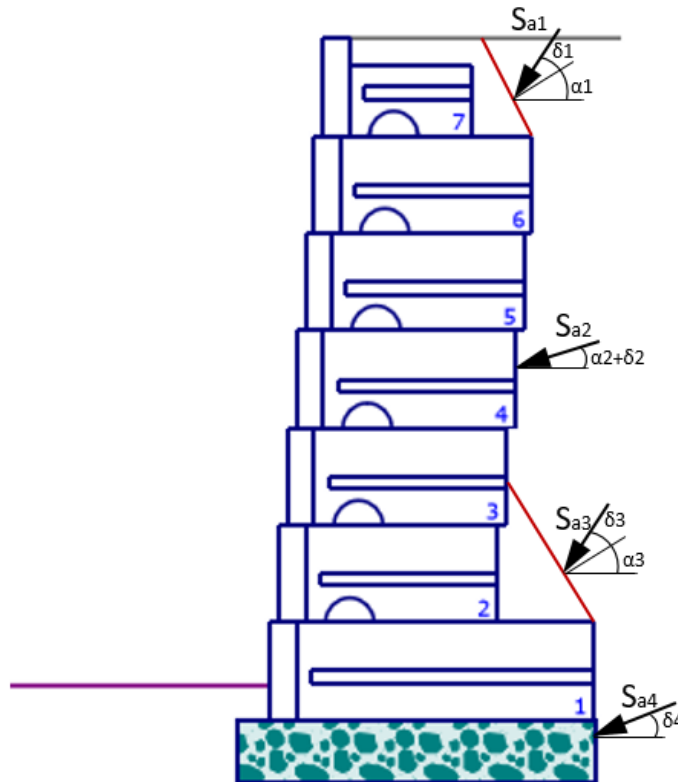


Figure 3 Active earth pressure – resultant forces

Calculation of the active pressure. The construction is divided into four levels, in each is calculated active earth pressure and resultant forces. Resultant forces of the active pressure are shown in Figure 3. The active earth pressure is calculated using Coulomb's theory.

- Coefficient of active earth pressure in all levels:
 α - back face inclination of the structure
 $\beta = 0^\circ$ - inclination of terrain
 Effective values from the Table 1 are used in calculation.

K_a - coefficient of active earth pressure

Checking for overturning stability. The moments calculated in the analysis rotate about the origin of the coordinate system (left bottom corner of the structure, Figure 1). Resisting moment M_{res} and overturning moment M_{ovr} are calculated for verification. Results are compared with results from the GEO5 – Redi Rock Wall program.

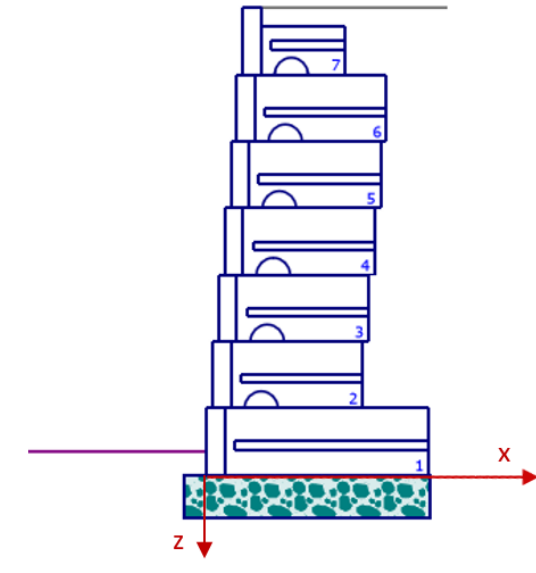


Figure 4 Dimensioning – joint between the block 1 and the footing

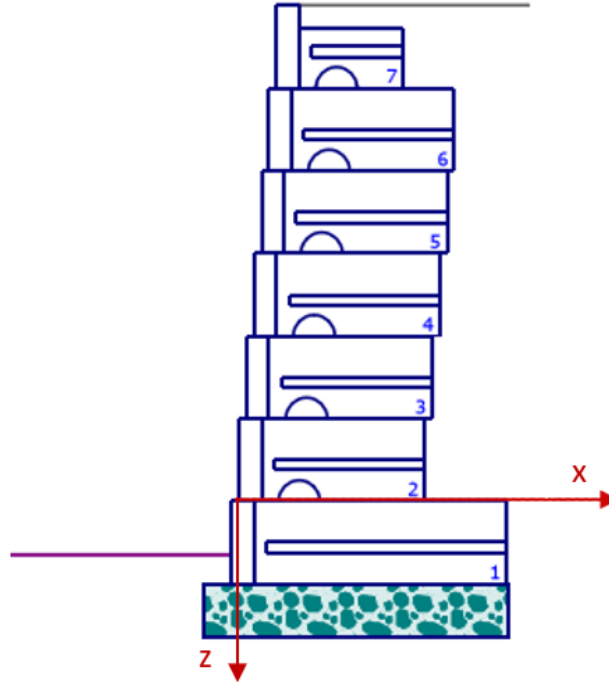


Figure 5 Dimensioning – joint between the block 2 and the block 1
